The Art Woodard Award for Diversity, Equity and Inclusion in the Recovery Community is given annually at our conference in honor of our dear friend Arthur Woodard. Art Woodard spent decades as a black man in a recovery community where he struggled to fit in with people who didn't look like him initially. Art found his recovery in that community and in giving back to it he had a magical ability to invite and welcome people into difficult conversations about race and build educational opportunity within our community. When we built our "Art & Science of Peer-Assisted Recovery" his contributions were so inspiring, with his permission we used one of his trademark teaching points around the "Art and Science of Peer-Assisted Recovery" that he would regularly talk about with eloquence. Art gave us permission before he passed away to have the name of that curriculum trademarked. That curriculum has now been taught to over 300 peers in six different states as far away as Oregon since October of 2019. His projects with his best-friend, Jim Wuelfing, on race, diversity, equity, power and privilege titled "Racism of the Well-Intended" have been screened, shown and taught to thousands in the recovery community across the United States. Art left us a gift in his legacy in the community that we can all cherish. It is one that encourages us to keep leaning into discomfort, keep challenging systems and structures around us that are predominantly controlled by white cis-gender power structures, keep pushing forward not just as allies but advocating as anti-racist and most of all, to do this work with love and compassion and to welcome our allies as well as those we don't agree with into these conversation and discussions. This award recognizes that and we hope to honor him by awarding this to one individual each year who contributes to our recovery community in a manner that is consistent with these principles and values.





#### **Keynote Speaker:**

#### Liz Evans

Liz has dedicated her career to working on behalf of marginalized individuals living in poverty and struggling with drug use and has had over 30 years of frontline experience. Her educational background includes a Nursing degree and a Masters in Adult Education.



As a former Open Society Foundation Fellow, and founder of the PHS Community Services Society, Liz has been instrumental in introducing housing first and harm reduction policies in Canada and was part of the visionary team that established North America's first legally sanctioned injection site in 2003.

More recently in New York, her tenure as Executive Director saw two renowned harm reduction organizations pioneer a drug users health hub, expand mobile outreach services, and significantly expand overdose prevention services while forming OnPoint NYC.

Presently, Liz is working as the Senior Director of Harm Reduction at Liberation Programs to advance harm reduction approaches and services for individuals at risk of overdose in Connecticut, in addition to working as a consultant.

## Topic: The History, Research and Impact of Safe Injection and Overdose Prevention Sites in North America

Liz will present the story of opening the first legally sanctioned injection site in North America as a key strategy for shifting the model of care to people who inject drugs across Canada and now in the US. She will present the history, the public education strategies, and the four-pillar framework used to introduce and eventually successfully open the model. She will present the key research findings upon its opening and briefly describe its operating model and how this led to the eventual establishment of over 40 different sites where people can legally consume drugs in Canada where overdose interventions take place on a regular basis.

Dr. Raagini Jawa is an Assistant Professor and Clinician Investigator in the Center for Research on Health Care, Department of General Internal Medicine at University of Pittsburgh Medical Center. She is board certified in Internal Medicine and Infectious Disease and Addiction Medicine. Dr. Jawa's research interests focus on the intersection of Infectious Disease and Addiction, including studying how to optimize integration of harm reduction services for individuals with substance use disorders within traditional health settings, developing multidisciplinary provider facing interventions to prevent infectious and non-infections complications of drug use. Clinically, she provides office-based addiction treatment in IM Recovery Engagement Program and attends the Endovascular Infection Service at UPMC.



#### **Keynote Speaker:**

#### **Dee-Dee Stout**

Dee-Dee Stout has undergraduate degrees in Business Management, Psychology & Human Sexuality from San Francisco State University (SFSU) where she also earned her Special Major Master's degree in Health Counseling. Dee-Dee is a member of the international Motivational Interviewing Network of Trainers (MINT), having received her training in MI in 2000 in part from the developer, William R. Miller, PhD. She is also a founding member of the California Association of Harm Reduction Therapists (CAHRT;



www.harmreductiontherapy.com). Dee-Dee is certified in Brainspotting, TFT, iRest, and has received specialized training and/or certification in more than 15 other approaches related to behavior change. Previously, she earned numerous designations in addiction work: LAADAC, CADC-II, MAC, and Gorski's Relapse Prevention Specialist among others. Dee-Dee chose to not renew those specialty accreditations a decade ago due mainly to their negative stance on harm reduction and few if any options to 12-Step.

Dee-Dee has worked in drug treatment for nearly 40 years. As well as maintaining a private practice (which she's had for more than 30 years) working with individuals, couples, and families, she regularly trains other behavioral health professionals in evidence-based, client-centered approaches and outcome-informed work. As someone with a long history of addiction, traditional recovery, chronic pain, & numerous (mostly incorrect) psychiatric diagnoses including PTSD, Dee-Dee has recently added "autistic" to her descriptions. What happens next, Dee-Dee continues to advocate for people who use drugs & their families and chronic pain patients with her wicked sense of humor.

Dee-Dee is currently Adjunct Associate Professor at St. Mary's College in Moraga, CA, in the Graduate Counseling Psychology department. Teaching college for more than 30 years at several Bay Area colleges and universities has been a calling for Dee-Dee. She has also made many public appearances as an invited speaker at conferences (including internationally) and been interviewed on television, radio, in film, podcasts, & print, discussing treatment, harm reduction, trauma-informed care, family coaching, and more. Dee-Dee has also contributed to various best-selling books on addiction as well as to scholarly papers on treatment issues including trauma.

Finally, Dee-Dee's ground-breaking book, "Coming to Harm Reduction Kicking & Screaming: Looking for Harm Reduction in a 12-Step World," is widely available and has received numerous positive reviews. Currently, she is working on a second edition of her original book with the writer, Joe Clifford, (author of "Junkie Love") due to be released in late Spring/early Summer 2024.

#### **Keynote Speaker:**

#### Mark Jenkins

Mark Jenkins, a service-connected disabled Veteran of the United States Air Force and Founder / CEO of the Connecticut Harm Reduction Alliance and Executive Director of Reduce Harm Inc. has worked in the field of Harm Reduction and Public Health for the past 27 years, delivering innovative prevention/interventions to the most vulnerable members of central Connecticut communities.

Mr. Jenkins started in the field as an AIDS Risk Reduction Outreach Worker (ARROW) for the Perception programs in Willimantic. In his subsequent work with Community Renewal Team (CRT) and the Hispanic Health Council, he further cultivated progressive strategies for reaching and delivering services to our most difficult-to-reach populations.

Mr. Jenkins's work in some of the most troubled neighborhoods in the state has given him a unique perspective of the history of drug trends, the dynamics of associated risks, and effective public health responses. Over a decade on the Staff at AIDS Project Hartford as a Drug Treatment Advocate providing HIV/HCV counseling and testing, syringe exchange, and other harm reduction services, Mr. Jenkins developed a service network of providers that continues to benefit both client and staff of the various providers alike. The breadth and depth of his connection with folks on the street and the service community has made Mark a well-respected and widely known individual in this field. He has presented nationally and internationally about best practices for working with the drug using community.

#### Topic: Breaking barriers in peer-based harm reduction and recovery support services

As a nationally recognized harm reductionist with lived experience in recovery Mark will discuss the barriers and challenges we face in breaking down barriers between the harm reduction and recovery communities. He will discuss opportunities for our communities to strengthen our work and challenges with the co-opting of peer-based services that continue to harm our work. This session will engage our audience for a larger interactive discussion to sort out some of the tensions, challenges, barriers and opportunities as we work towards a world where compassion and love for our communities can bring us all together.
